**THE UNIFORM FIRE CODE:**

*"It shall be unlawful to engage in any business activity involving the handling, storage, or use of hazardous substances, materials, or devices; to maintain, store, or handle materials; to conduct processes which produce conditions hazardous to life or property; to install equipment used in connection with such activities; or to establish a place of assembly without first obtaining a permit from the fire official. (NJAC 5:18-2.7 9a)*

NOTE: Each individual act requires a separate permit. There are five (5) types of permits. You should consult your Fire Official for the number and types of permits required and for information on fees.
